- This product is NOT a flotation or life saving device.
- This product is not a toy. It is intended solely for lounging by adults or children 6 and over, under adult supervision.
- Remain seated in the designated sitting area at all times when using product.
- Keep product out of reach of children when not in use.
- Make sure all children are supervised in or around the pool. There is no substitute for constant adult supervision. Small children and all non-swimmers should always be within arm's reach of an adult when using the pool.
- When used by children, make sure product stays in shallow area of the pool.
- Keep product away from the pool and stored when not in use; otherwise it can lure a child into the pool.
- Do not stand on, dive or jump onto or from this product.
- Use caution and make sure an adult is holding product when boarding.
- Do not exceed 300 lb. weight limit.
- Check inflation of product before using. Cooler weather may cause loss of pressure. Do not use if under inflated.
- If product is leaking or appears scratched or damaged do not use.

DO NOT OVER INFLATE!

INFLATING

1. Locate a clean area free of stones or other sharp objects.
2. Unroll the product so it is laid out flat with head facing up.
3. Use a hand or foot operated air pump to inflate the product.
4. Inflate each section of the product slowly to about 90% of its capacity.

NOTE: Inflate in the order of: 1. Main body 2. Inner seating area 3. Head

5. Finish inflating each section slowly until it is firm to the touch but NOT hard.

IMPORTANT: Air temperature and weather condition do affect the internal air pressure of inflatable products. In cold weather, the product will lose some pressure due to the fact that the air will contract. If this occurs, you may want to add a little air to the product. However, in hot weather, the air will expand. You must let some air out to prevent the product from failing due to overpressure.

CARE, MAINTENANCE & STORAGE

IMPORTANT: Remove from pool when not in use or while cleaning so unit is not damaged by skimmers or other devices.

Wipe dry with a soft cloth after use. When the product is out of water, it should be cleaned and dried thoroughly and stored in a cool, dry place.

REPAIR

1. Deflate the product
2. Clean the defective area
3. Cut round or oval patch
4. Remove the paper backing
4. Apply sticky film to repair area
5. Squeeze out all air bubbles
6. Wait at least 20 minutes before inflating

MAKE SURE REPAIR WAS EFFECTIVE AND PRODUCT RETAINS AIR BEFORE USING.
